4. UPDATE ON RECENT SALES OF TIMBERWEST LAND IN OTTER POINT

TimberWest has recently sold three of their forest land properties in Otter Point.

[Canadian Horizons Land & Investment Corporation](#) purchased 559 acres, located behind the Otter Point fire hall, in September. Their tentative development plans

were mentioned in last month's newsletter. Their Manager of Development recently met with the OPSRRA directors and provided the following up-date:

- The company has applied to be included in one of the proposed Otter Point Settlement Containment Areas. This would allow them to apply to bring CRD water to their development and to apply to subdivide their property into 2.5 acre residential sites. Under the CRD's Regional Growth Strategy, CRD water may be extended to a Settlement Containment Area with the approval of the CRD Board of Directors. An application to change the zoning on the property would need to go to the JDF Electoral Area Land Use Committee and a public hearing and would likely be referred to the Otter Point Advisory Planning Commission.
- If they are unable to subdivide their property, Canadian Horizons has indicated that they will proceed with creating a 4-on-10 development. This means that each 10 acre parcel would be strata-titled to accommodate 4 homes. Allowing land for roads, green space and other community uses, they estimate that their property could accommodate 164 homes.
- Survey and water management work is now underway in preparation for the submission of a preliminary subdivision application.

Island View Construction has just purchased the old TimberWest log sort off Otter Point Road at Butler Main. Most of this 47.7 acre parcel is zoned Industrial, with a small rural parcel. OPSRRA organized a meeting between the new owner and representatives from the Kemp Lake Waterworks District, Otter Point fire trustees and the Juan de Fuca Community Trails Society. The purpose of this meeting was to:

- Discuss how the Kemp Lake watershed would be protected from industrial activity and storm water and wastewater run-off. Most of the property resides within the watershed.
- Discuss how a community trail could be provided across the property to ensure public access between the Crown land on Broom Hill and the developing trail system in Otter Point.
- Ask if the company intended to join the Otter Point fire protection district.
- The meeting was also an opportunity to hear about the company's preliminary development plans and to allow them to develop contacts in the community.

Island View Construction has provided OPSRRA with the following information about their plans to develop the property.

The 47 acre TimberWest Dryland Sort property has been purchased by Three Point Properties Ltd. and Island View Properties Ltd, under a company named Otter Point Properties Ltd. The joint venture is a comprehensive development to be named Sooke Business Park. The general contractor for the project will be Island View Construction Ltd.

When complete Sooke Business Park will consist of industrial land with office and warehouse space available for lease or purchase. The number of lots is currently un-determined, and sizes will start at 1/4 acre. A website is being developed at www.sookebusinesspark.com

3L Developments Inc. of Nanaimo has made an offer to purchase the parcel of forestry land bordered by Otter Point Road, Young's Lake Road and Camp

[Barnard](#). This deal is expected to close on December 4. They have indicated that they intend to apply for rezoning from Rural "A", which allows one dwelling on 10 acres, to RR2 which allow for one dwelling on 2.5 acres. Their first step has been to request that the property be included within a Settlement Containment Area in the proposed Otter Point Official Community Plan.

5. OPSRRA PRESENTATION TO THE OTTER POINT OFFICIAL COMMUNITY PLAN (OCP) PUBLIC HEARING

OPSRRA made an official presentation at the November 6 Otter Point Official Community Plan public hearing. The public hearing was the last opportunity for the community to express their opinion on this OCP. The public hearing was well attended with about 40 people present and there were about a dozen presentations from individuals and organizations. The recurring themes were:

- The inaccuracy of the maps attached to the OCP.
- The need to identify and protect eco-sensitive areas.
- The need to acquire, protect and improve access to community trails.
- The location of some of the boundaries for the proposed Settlement Containment Areas.

Note: OPSRRA also collaborated on one of the presentations made at the Shirley/Jordan River OCP public hearing on November 14.

Last Minute Update: As a result of the problems identified in the Otter Point and Shirley/Jordan River OCPs at the November public hearings, a decision has just been made to return these two OCPs to the December 5 Land Use Committee (LUC) with a recommendation that further revisions be made. If this is agreed to by LUC, these two OCPs would need to go to another public hearing. The East Sooke OCP is proceeding as proposed and is not affected by this decision.

6. RESOURCE LANDS OFFICIAL COMMUNITY PLAN

The CRD and the JDF Electoral Area are presently collaborating on a first time Official Community Plan (OCP) for the vast area north of Otter Point and Shirley - up to the Cowichan Regional District, and west of Jordan River to Port Renfrew. This area is outside of the boundaries of the recently completed OCPs for Otter Point, Shirley/Jordan River and Port Renfrew. It is being referred to as the Resource Lands OCP. The following information has been submitted to the OPSRRA newsletter by Gerard LeBlanc who recently completed a contract as the planner/administrator for the Juan de Fuca Electoral Area (JDF EA) and has been hired to draft the Resource Lands OCP.

The JDF EA Planning Services has undertaken the preparation of an OCP for the area between Shirley/Jordan River and Port Renfrew. Gerard V. LeBlanc of Landworks Consultants Inc. has been contracted to complete the project.

Considered as a resource lands area within the context of the CRD Regional Growth Strategy, existing use and Provincial interests, this OCP will focus on resource, tourism and recreational development in the plan area. The proposed OCP is anticipated to focus on the resource issues of the area, the guiding principles of the Regional Growth Strategy, provincial land use planning interests, Crown, TFL and private forest tenures and existing parks and trails. The proposed OCP is currently at the data gathering and inventorying stages and will proceed through a public process prior to approval.

7. OPSRRA COMMUNITY NOTICE BOARDS

8. OTTER POINT VOLUNTEER FIRE DEPARTMENT ANNUAL GENERAL MEETING

The Annual General Meeting for the Otter Point Volunteer Fire Department was held on Tuesday, November 14. The following individuals were re-elected as trustees for a two year term:

9. RETIREMENT OF OTTER POINT FIRE CHIEF

John McCrea will be retiring as the Otter Point Fire Chief in January 2007. John has had a lengthy career with the fire department and has been fire chief for the past 10 years. During this time the fire department has up-graded its equipment, built the new Fire Training Centre and maintained its quota of volunteer firefighters. OPSRRA wishes to thank John for his contribution to the community as our fire chief and for the endless hours he has spent attending community meetings on behalf of the fire department and opening the fire hall for community meetings.

John is remaining as a volunteer fire fighter with the Otter Point Fire Department. A new chief will be appointed by the Fire Trustees in the New Year.

10. DEVELOPING A STRATEGIC VISION FOR OTTER POINT & SHIRLEY

This OPSRRA project is underway (see the November 2006 newsletter for details). Letters were recently sent to about 30 local and regional organizations inviting them to participate in developing a long-term vision for the two communities of

Otter Point and Shirley. A deadline of December 15 has been set for interested individuals and groups to reply. Following that deadline, the OPSRRA Board of Directors will decide if there is enough interest in this project to proceed to the next step, which would be the formation of a steering committee.

11. CAPITAL REGIONAL DISTRICT LONG TERM PLAN

The CRD recently completed a draft of their proposed long-term plan called *Capital Regional District – Focus, Performance and Accountability*. OPSRRA reviewed the document and felt that it needed comment from the Electoral Area. As the JDF Regional Director was not going to comment, we decided that we should. Here is our submission and covering letter.

Dear Mr. Daniels:

I am writing on behalf of the Otter Point & Shirley Residents & Ratepayers Association (OPSRRA) in response to the Capital Regional District's request for comment on the proposed *Capital Regional District Plan – Focus, Performance and Accountability*. OPSRRA was not one of the community organizations asked for comment: we received the draft plan second-hand from another organization who was asked to comment but felt they could not.

Although our attached comments will seem critical of the plan, they are intended as critical comment and not criticism. Our association supports the CRD's efforts to improve CRD services through-out the region and we have publicly supported and participated in planning documents such as the Regional Growth Strategy and our local OCPs. Our objection, in this instance, is that communities in the Electoral Areas, such as Otter Point and Shirley, don't seem to be part of this proposed plan.

As the refinement of the plan proceeds to its final stages, prior to adoption in January 2007, we request that consideration be given to allowing OPSRRA an opportunity to present a formal and comprehensive critique of the plan. The attached report provides examples of areas where we feel that the Electoral Areas have been overlooked and where a regional plan such as this would benefit from a further review from an unincorporated area instead of just an incorporated municipal perspective.

[Some thoughts](#) about the CRD's Strategic Plan – Focus, Performance and Accountability: solely from a Juan de Fuca Electoral Area point of view.

1. It is noteworthy that although the document describes the CRD as a "vision-driven federation of municipalities and electoral areas", there is almost no reference to electoral areas in the document other than noting that one of the purposes of the CRD is to "serve as local government for electoral areas and provide contracted services"
2. Electoral areas are the "lost orphan" in the document as there is no vision for their future; no recognition of their concerns; no focus on the CRD's local governance performance; and no strategic planning dealing specifically with electoral area priorities.

To illustrate, when looking at the strategic priorities listed in the document:

- The growth management strategic priority envisages approving the remaining regional context statements in four urban municipal OCPs while making no reference to approving new JdF Electoral Area OCPs or zoning bylaws. Nor is any potential strategy proposed to manage growth pressures and conflicts between urban municipalities and rural electoral areas.
- The environmental protection strategic priority identifies an "ongoing commitment to watershed management in areas directly affecting CRD water supply" but makes no similar reference to watershed management for potable water sources for residents in the JdF Electoral Area for whom CRD water supply services are not provided. The proposed CRD strategic plan has quite different and unacceptable priorities for its incorporated and unincorporated areas when it comes to protecting and managing watershed sources for electoral area communities.
- The regional transportation strategic priority focuses almost exclusively on issues largely specific to the CRD municipalities. No reference is made to support plans to establish alternate transportation routes into and out of the JdF Electoral Area.
- The liquid waste/sewage strategic priority proposes "working with partners to develop a consistent region-wide septic public education, monitoring and enforcement program." This has some potential to assist the unincorporated areas to deal with the negative environmental and health effects of ineffective septic systems. However, within the JdF Electoral Area, monitoring and enforcement should be initially prioritized for older septic systems located around high risk areas such as watersheds providing potable water and areas draining into coastal or riparian areas.
- The organizational performance strategic priority is striking for the total absence of any reference to reviewing, assessing or improving the CRD's performance in one of its core missions, "serving as "local government for electoral areas." Many residents within the JdF Electoral Area are both critical and dissatisfied with the local governance role of the CRD - viewing it as unresponsive to local concerns and largely unaccountable to local residents for many of the local decisions it makes. A review of the focus, performance and accountability of the CRD in its local governance role for unincorporated areas is essential for improvements to occur. Priorities should include:
 - A public survey examining public satisfaction with the local governance role of the CRD;
 - The creation of public forums for discussion of the local governance role of the CRD;

- An independent review of the accountability and effectiveness of the CRD's local governance decision making structures;
- Greater public transparency in identifying annual revenues and expenditures in each electoral area.

12. TIMBERWEST REPLY TO MUIR CREEK PROTECTION LETTER

TimberWest replied to a recent letter that OPSRRA sent to them expressing our association's thanks for TimberWest's decision to hold-off logging in the vicinity of Muir Creek and a part of the Muir Creek watershed, pending a decision from the CRD to help purchase some of this area as a regional park. The concluding paragraph in their letter makes it apparent that TimberWest intends to look at uses, other than forestry, for its properties. The recent sale of three large parcels of their forest lands, in Otter Point, in the past few months would seem to confirm this. As one of the three largest land owners in this area (the Province and Western Forest Products are the other two), their use and disposition of land will certainly impact the future development of our area. OPSRRA has invited both TimberWest and Western Forest Products to participate in the Developing a Strategic Vision project.

13. REPLY FROM MINISTRY OF TRANSPORTATION REGARDING ROAD SAFETY

OPSRRA wrote the Ministry of Transportation last month (see the November newsletter) concerning speeding and road safety issues. They replied:

Dear Mr. Campbell:

I am writing in response to your letter of October 27, 2006, to Bob Webb in which you request signage and maintenance improvements on the roads within your community. I will respond to your points in the order you presented.

Shoulder mowing is delivered by our contractor throughout the year on all roads subject to fire season closures. I do not control the schedule as the contractor is responsible for resourcing the manpower and equipment to delivering the activity across the service area south of Ladysmith.

Shoulders on all roads are not graded on an annual rotation. When the work is being identified the contractor is checking for situations where the shoulder is eroded by water or traffic or where the road surface water can not flow to the ditch. Most of the side roads in your area have narrow grassed shoulders that do not require this type of maintenance. Removing the sod from the shoulder also often requires a reapplication of gravel. By copy of this letter I will forward your request to the Maintenance Contractor for consideration.

All roads leading to the local area, Otter Point Road, Kemp Lake Road, and Woodhaven Road are suitable posted at a 50 km/h maximum. All motorists pass these signs prior to turning onto a no exit road so additional speed signs are redundant and unnecessary.

I have recently ordered the installation of No Exit signs for Robinson Road, Amanda Road, Otter Point Place Anderson Road and Woodhaven Road. Some will be installed on the back of the existing Stop signs while others will be new installations because the back of the stop sign can not be seen by approaching traffic.

The ministry does not install traffic calming devices on roads under our jurisdiction as they have the potential of creating safety issues for emergency responders and maintenance operations.

Finally, we do not have control over unlicensed, underage dirt bikers without helmets that use the roadways, this is an enforcement issue. You may want to contact the RCMP.

14. DID YOU KNOW THAT?

Muir Creek was named after the pioneering Muir family? They first came to this area in 1851 and within 25 years had built a thriving logging, sawmill and shipping business. Muir Creek is about 15 kilometres long with its headwaters near Mount Muir and has a watershed of about 6700 square kilometres.

Kirby Creek in Shirley was originally called Coal Creek? Early coal exploration in the area accounted for the first name, however the pioneering Kirby family began homesteading on the northeast side of the creek in the early 1900s and by 1920 the creek was referred to as Kirby Creek.

Information for this month's **Did You Know That?** is from *4000 Years—A History of the Rainforest* written and published by the Sooke Region Museum and from information on Muir Creek prepared for the Muir Creek Protection Society by David Glenn.
