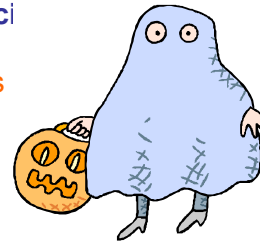

## 5. SEASONAL FIRE BURNING REGULATIONS

The following information is from the Otter Point Fire Department web site, [www.otterpointfire.bc.ca](http://www.otterpointfire.bc.ca). Similar regulations apply to the Shirley Fire Protection District. Contact your local fire department for further details.

### Fire season is April 1 to October 1

The season may be extended at the discretion of the Fire Chief.

Class 'A' and class 'B' fires require a permit from the fire department. See below for definitions of Class 'A' and 'B' fires.

Please leave a message and the person issuing permits will return your call.

### Prohibited Materials

The following shall NOT be burnt:

- Tires
- plastic
- drywall
- paint and paint products
- treated lumber
- asphalt
- asphalt products
- rubber
- fuel
- solvents
- metals & lubricant containers
- tar paper
- railway ties
- demolition waste
- garbage
- biomedical waste
- manure
- as well as other material that may be listed under the BC Ministry of [Environment Open Burning Smoke Control Regulation](#).

### Class A Fires

Between October 1 and June 30 burn allowed: permits required

Between July 1 and September 30 **NO burning at all**

Burning of any piles larger than 2 metres in diameter and 1 metre in height requires a permit from the fire department.

No person shall burn land clearing waste:

- within 50 meters of buildings on the same property
- within 50 meters of the works or facilities of any utility
- within 100 meters of a neighbouring residence or business
- between a building and a highway
- for more than 3 consecutive days

No person shall add additional materials to a fire within 2 hours of sunset of each day of the fire.

### **Class B Fires**

Between April 1 and June 30 burn allowed: permits required

Between July 1 and September 30 **NO burning at all**

Between October 1 and October 31 burn allowed: permits required

Between November 1 and April 1 burn allowed: permits required

Class B limits on hand pile burning shall be maximum diameter 2 metres (6 feet) and a maximum height of 1 metre (3 feet).

No green debris or leaves shall be burnt except by specific exemptions which may be at the discretion of the Fire Chief.

No person shall add additional materials to a fire within 2 hours of sunset of each day of the fire.

### **Beach and Camp Fires**

Beach and camp fires are allowed all year round **except during Extreme Fire Hazard periods.**

Beach and camp fires shall not exceed 1 metre in diameter and 1 metre in height.

All beach and camp fires must be contained by a suitable receptacle made of fire proof materials (such as rocks or metal) that completely surround the fire.

Fires are to be continuously controlled and supervised by a competent person until fire is completely extinguished.

### **Incinerators**

Incinerators with a proper screen do not require a permit.

Incinerators can be used all year round **except during Extreme Fire Hazard periods.**

The owner of any incinerator shall:

- maintain the incinerator in a condition that provides for the proper combustion of any material burned;
- ensure that any burning is supervised and that any equipment necessary for fire control is available;
- ensure that the domestic incinerator is located at least:
  - 1.5 metres from any grass, shrubbery or wooden fence; and
  - 7.6 metres from any building;
- ensure that the commercial or industrial incinerator is located at least:
  - 3 metres from any grass, shrubbery or wooden fence; and
  - 10 metres from any building

## 6. VOLUNTEER RECOGNITION

The OPSRRA newsletter was asked to circulate the following request from the District of Sooke.

The District of Sooke recognizes that volunteerism has played a major role throughout the history of Sooke in the betterment of the community in a great variety of ways. For example, the Sooke Community Association was formed in 1934 to help raise money for a new community hall and has been called "one of the most effective volunteer civic groups in Canada". With over 120 known volunteer organizations in the area, Sooke has claimed the name "Volunteer Capital of Canada" and now proudly displays the title on the new "Welcome to Sooke" sign.

The District of Sooke chose 2001, the International Year of the Volunteer, to initiate a program recognizing long-time volunteers who have made significant contributions of benefit to Sooke and/or the surrounding region. This program is now ongoing on a bi-annual basis with the next Volunteer Recognition Ceremony to be held in January, 2010.

The District of Sooke invites everyone to recognize Sooke Region's outstanding volunteers by nominating a citizen for a Sooke Volunteer Award. Nomination forms are available at the District of Sooke Municipal Hall, on our website, and the Sooke Region Museum. Nominations will be accepted until October 31, 2009 at the Municipal Hall.

## 7. SEAPARC RECEIVES FEDERAL/PROVINCIAL FUNDING FOR UPGRADES

The Sooke and Electoral Area Parks & Recreation Commission (SEAPARC) has received \$800,000 in shared provincial and federal funding to undertake renovations and maintenance upgrading at the SEAPARC Leisure Centre on Phillips Road in Sooke. This infrastructure grant money will be matched by \$400,000 put aside by SEAPARC for work on the complex. SEAPARC has submitted the following information to the OPSRRA newsletter detailing the activities of SEAPARC and the work that will be covered by the grant.

### Project Description

Sooke and District Arena is part of the SEAPARC Leisure Complex. The complex includes an ice surface, aquatic centre, program and meeting spaces and a slo-pitch ball field. The arena was completed in 1976; the aquatic centre and other spaces were completed in 2000. The primary objective is to refurbish and replace the aging mechanical and refrigeration systems, add two new dressing rooms and refurbish the four rooms in existence.

### Project Benefits

The ice arena and aquatic centre presents a unique opportunity for Integrated Resource Management. The heat wasted from the ice plant refrigeration and snow

melt operations could be recovered and used to pre-heat the pools at the aquatic centre and space heating. The project will also focus on reducing the carbon footprint of this facility. Technologies such as water recycling, solar hot water and thermal energy will be investigated. New spaces will follow LEED standards. Current dressing room spaces will be upgraded to current health and accessibility standard. A significant benefit will be the increased capacity of our facility to accommodate 60 skaters for practice ice, versus 30 skaters due to lack of change room space; as well, female hockey players will have access to space that is currently very limiting when mixing the sexes for hockey practices and games. The new and/or refurbished equipment will be safer than current equipment. The arena lifespan will be extended another 20 years.

**Note:** SEAPARC is supported by the taxpayers of both the District of Sooke and the Juan de Fuca Electoral Area. Director Hicks and one appointed resident from the Electoral Area sit on the SEAPARC Board of Directors.

## **8. CRD PLANNING SERVICES OPEN HOUSE: RURAL RESOURCE LANDS LAND USE BYLAW AND OFFICIAL COMMUNITY PLAN**

On September 21, the CRD Planning Services staff held an Open House followed by a staff presentation and Question and Answer session on the proposed Rural Land Use and Official Community Plan bylaws for the Rural Resource Lands. See the September newsletter for a detailed explanation of the bylaws and the area they cover.

The main points covered at the Open House were:

- That the intention of the proposed bylaws is to keep the Rural Resource Lands rural and not as an area for residential development.
- The CRD's Regional Growth Strategy (RGS) is the umbrella legislation and the proposed bylaws have to conform to that legislation.
- That limited opportunities for tourism should be accommodated.
- That a small amount of rural residential development should be accommodated in areas next to established development.
- No publicly supported infrastructure would be allowed to accommodate further development.
- That the present 120 hectare parcel size for subdivision (Bylaw 189) does not specify how many dwellings could go on the parcel.
- The new land use bylaw, if approved, would limit the number of dwellings on 120 hectares to one dwelling.
- Strata-titling to increase density would not be permissible under the proposed land use bylaw.
- CRD Planning staff are recommending that property owners be allowed to apply for rezoning to less than 120 hectares under certain criteria to accommodate lot averaging, small rural residential development, tourism and resource activities such as agriculture, Silva culture, forestry and resource processing on smaller than 120 hectare parcels.

The next steps are to have a final staff report go to the JDFEA Land Use Committee (LUC) on October 20. If accepted, the proposed bylaws would then go to the CRD Board for discussion by the full Board of Directors; but only Committee A (consisting of the JDFEA Regional Director and the representatives to the CRD Board from the District of Sooke, City of Colwood, City of Langford and District of Metchosin) would be allowed to vote on sending the proposed bylaws to public hearing. If any municipality or district in the Capital Regional District feels that the proposed bylaws do not conform to the CRD's Regional Growth Strategy (RGS)

they are entitled to register their opposition and this could result in the process being delayed or the proposed bylaws rejected as written.

**Note:** OPSRRA directors will be drafting a presentation to be given at the Public Hearing. Members will have an opportunity to review these draft comments at our November membership meeting.

## **9. WHAT HAPPENS NEXT NOW THAT THE VOTING SYSTEM FOR CRD BYLAWS IN THE JUAN DE FUCA ELECTORAL AREA WAS FOUND INVALID?**

A letter to our Regional Director, in last month's newsletter, detailed a request from OPSRRA for an update on what would happen now that the B.C. Court of Appeal has upheld an earlier Court decision regarding the validity of the voting system used between April 2006 and December 2008 to pass Juan de Fuca Electoral Area bylaws.

Director Hicks has sent OPSRRA the following reply to our letter.

---

In response to your letter outlining your concerns with the court decision, the following has happened:

- 1) The CRD Board voted to "Not" appeal the decision
- 2) Community and Rural Development Minister Bill Bennett announced that he will "Not" use the Municipal Enabling and Validation Act (MEVA) to re-instate the disputed bylaws affecting the Rural A landowners and WFP lands.

Mr. Bob Lapham, our Manger of CRD Planning will now work with Mr. Bennett's senior staff. They will be looking at the possibility of using MEVA to avoid legal challenges to our OCP and base bylaws. I totally support all these actions. Our Rural A landowners are at peace, we are rapidly moving towards formulating a plan for the WFP Resource Lands removed from the TFL, and I believe working together towards solving a major problem.

Some will be critical of saving the OCPs but in my view, we have neither the funds, staff nor time to start from scratch. After we finish working on the mammoth task of the Resource Lands OCP (this year), we will have an intensive review of the Otter Point, Shirley and East Sooke OCPs and make any necessary changes.

I hope this answers your questions.

## **10. OTTER POINT, SHIRLEY & JORDAN RIVER STRATEGIC VISION "REUNION"**

The **Otter Point, Shirley and Jordan River Developing a Strategic Vision Project** concluded in February 2009 with a final meeting of the project's Advisory Committee. However, there was a "reunion" of the Strategic Vision Project Advisory Committee on September 30. This was in response to a request from some committee members who felt that it would be useful to continue to meet to review

what activities different groups were undertaking in support of the Otter Point, Shirley & Jordan River Strategic Vision. Seventeen individuals (representing about twenty community organizations, land development companies and local area commissions) attended the September meeting. The round table exchange of information provided many examples of how the project's final report is being used to help with planning decisions in the community. The group has suggested meeting again in six months to repeat the process. OPSRRA will undertake to organize these on-going reunions.

## 11. DID YOU KNOW THAT ...

**Captain Juan de Fuca, after whom the Strait of Juan de Fuca and our Electoral Area is named, was not a Spaniard but from Greece?** Apostolos Valerianos, also known as Juan de Fuca, was born on the Island of Cephalonia in the Ionian Sea. He journeyed to Spain and spent 40 years as a mariner and pilot in the service of that country. In the late sixteenth century he was based out of Mexico, which at that time was part of the Spanish Dominion. It is believed that he sailed into our local waters in 1592 and is thought to have been the first European to have sighted Cape Flattery, located at the western tip of the Olympic Peninsula in present day Washington State. He is mentioned in the journals of Captain Cook who explored this part of the West Coast on his Voyages of Discovery in the 1770s. There are two different accounts as to who named the Strait after him. One says that it was John Mears in 1788 and another says that it was Captain Barclay of the British ship the Imperial Eagle in 1787.
